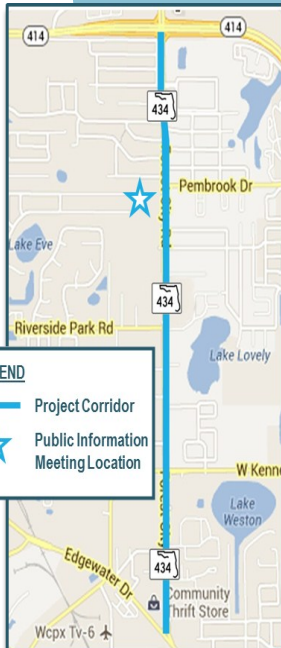

The FDOT will conduct a public information meeting on proposed improvements for State Road (S.R.) 434 (Forest City Road) from S.R. 424 (Edgewater Drive) to S.R. 414 (Maitland Boulevard) in Orange County. Project Summary

Proposed Improvements

- ◆ S.R. 434 (Forest City Rd.) between S.R. 424 (Edgewater Dr.) to S.R. 414 (Maitland Boulevard)

What will we be doing?

- ◆ Widening S.R. 434 to a six-lane divided highway
- ◆ Expanding three existing ponds
- ◆ Upgrading signal poles to mast arms
- ◆ Adding bike lanes, sidewalk, and curb and gutter

When will this happen?

- ◆ Design slated to be completed October 2019
- ◆ Estimated construction cost is \$12.2 million
- ◆ Project is funded for construction in the 2021 Fiscal Year.

This meeting is being conducted to give interested persons an opportunity to express views concerning the proposed improvements.

Public Involvement

Project History

The FDOT initiated a project development and environment (PD&E) Study in 1996 to study S.R. 434 (Forest City Road) from S.R. 424 (Edgewater Drive) to S.R. 414 (Maitland Boulevard) in Orange County. A second public hearing was held on July 26, 2011. A public information meeting was held August 29, 2013.

Project Description

S.R. 434 (Forest City Road) is primarily a 4-lane divided north-south roadway. The proposed improvements involve widening S.R. 434 from a 4-lane divided roadway to a 6-lane divided roadway from S.R. 424 (Edgewater Drive) to S.R. 414 (Maitland Boulevard). The roadway will consist of three travel lanes, sidewalks, and bike lanes in each direction, with a raised curbed median. The primary purpose of this project is to enhance safety and relieve congestion along this segment of S.R. 434.
